#### 1. PROMOTION OVERVIEW

The Promotion is organised by AXIORY GLOBAL LTD and TRADIT LTD (together hereinafter referred to as "AXIORY") and will run from **05<sup>th</sup> August 2024 00:00 GMT+9 until 31<sup>st</sup> August 2024 23:59 GMT+9**, giving you the opportunity to win a prize pool of up to USD 60,000 in the lottery draw by-fulfilling certain checkpoints and conditions in terms of traded volume, subject to these Terms.

#### 2. ELIGIBILITY CRITERIA

The Promotion is open to all clients aged 18 years or over who:

- Have registered a demo AXIORY trading account;
- Have registered a live AXIORY trading account by providing the necessary identification documentation;
- Are eligible to trade as per AXIORY's onboarding Client Agreements; and
- Have agreed to these Terms.

While users of demo accounts are welcome to participate, only those with a live AXIORY trading account who traded at least 5 lots in the period of this promotion will be eligible for the lottery prize.

This Promotion does not apply to clients who trade only on the Alpha account.

### 3. PROMOTION RULES

- 3.4 For purposes of becoming eligible to enter the lottery draw and earn lottery tickets by sharing a post or video on Social Media, you will be required to use specific hashtags chosen by AXIORY and include URL link to dedicated campaign webpage on AXIORY's website in the post.

- 3.7 The selection via an algorithm will be performed retrospectively at the end of the campaign (31<sup>st</sup> August 2024 23:59 GMT+9) and in order to remain eligible for the lottery win, the posts on Social Media must not be deleted and must be accessible until the winners are announced by 04<sup>th</sup> September 2024.
- 3.8 The lottery winners will be drawn per prize and we won't do move-up lottery but we will re-do the selection from all the participants (all lottery tickets) in case the winner chosen by the algorithm is not eligible or declines the reward.
- 3.9 The Promotion may be combined with any other credit or cashback received on trading volume which AXIORY may offer from time to time.
- 3.10The Promotion is available on a per-client basis (not on a per-account basis), regardless of the number of accounts held with AXIORY.
